What is Wisbankpac?

Wisbankpac is the registered political action committee of the Wisconsin Bankers Association. Wisbankpac supports pro-banking candidates throughout Wisconsin by pooling individual banker contributions in order to maximize their overall impact in the political process. Wisbankpac is the only PAC that represents the entire Wisconsin banking industry and can support candidates for both state and federal office. Wisbankpac is registered with the Wisconsin State Elections Board and the Federal Election Commission and all contributions and disbursements are reported.

Why should bankers contribute?

As bankers, we all have a stake in the future viability and competitiveness of our industry. That future is largely determined by the Wisconsin Legislature and U.S. Congress. That's why bankers need to help support and defend banking's positions against a growing list of competing interests. By far the best way to do that is to contribute to Wisbankpac.

Who does Wisbankpac support?

Wisbankpac supports candidates of both parties who understand the important role banking plays in maintaining a strong Wisconsin economy.

What is the Leadership Circle?

By making a contribution of at least \$3,000 to Wisbankpac, bankers will become a member of WBA's Leadership Circle — WBA's highest level of recognition for **individual** political action giving. Members receive special recognition at the end of the year.

What is the Silver Triangle Club?

By making a contribution of at least \$1,000 to Wisbankpac, bankers will become a member of WBA's Silver Triangle Club — WBA's second highest level of recognition for **individual** political action giving. Members receive special recognition at the end of the year.

How much should I give?

Here are suggested contribution levels:

- **\$100 – \$500**
for administrative staff and junior officers
- **\$500 – \$1,500**
for vice presidents
- **\$1,500 – \$3,000**
for executive officers and directors

Deciding whether to contribute and what amount to contribute are personal and voluntary decisions. No advantage or disadvantage may occur to anyone based on their decision to participate to Wisbankpac.
